## Conditions

### Applicable to Pearson Aviation Pty Ltd Airline Pilot Licence course

1. Course duration of 52 weeks is based on:
  - Good flyable weather;
  - No loss of flying days due to illness, mechanical problems or any event beyond the control of the Company;
  - The average student's ability to progress.
2. Additional flying hours above those allocated may be required to achieve any particular level of licence or rating. Any additional hours required achieving any particular level of qualification or rating shall be paid for by the student at the then applicable hourly hire rate plus applicable landing/movement fees.
3. Provision of the course will be subject to written contract.
4. Students will be required to meet minimum attendance requirements to complete the course in the allocated 40 weeks.
5. The company does not warrant any student will complete the course in 40 weeks and or 187.5 flight hours.
6. All flight operations are subject to the Company Terms and Conditions of Hire, Company Operations Manual and its supplements and such other operational documents as are issued from time to time by Company management.
